The Details

Salary: Salary for Engineer IT Girls one-week resident camp including prep time and training is \$1,250 per instructor. Salary for Minds for Design two-week day camp including prep time and training is \$2,500 per instructor.

Training: All teachers will be fully trained in the program curriculum and will work collaboratively with experienced Girl Scout staff to implement the program.

Transportation: No transportation is provided, except for field trips.

Qualifications: You do not need to be a teacher to apply. We are looking for candidates with excellent leadership skills who have strong interest and experience in working with youth. Background in engineering, science, or math preferred.
